## Fanatics Holding, Inc. Privacy Notice (Last updated 3/13/23)

The privacy of our visitors is important to us. This Privacy Notice explains how Fanatics Holdings, Inc. ("we," "us," "our" or "Fanatics Holdings") handles personal information about you ("user" or "you") that we collect, use, and share through our website where this Notice is posted (the "Site"), as well as lets you know how you can review and update this information.

From time to time, we will update or make changes to this Privacy Notice. If we do, we may provide you with additional notice (such as adding a statement to our homepage). We encourage you to review the Privacy Notice whenever you access the Site or otherwise interact with us to stay informed about our information practices and your choices.

## 1. Sources of Personal Information

a. <u>Directly From You</u>: we may collect personal information during your access or use of the Site, such as when you browse or interact with our Properties or contact us for customer service or other assistance.

b. <u>Cookies and Other Tracking Technologies</u>: when you access or use the Sites, we may collect data using cookies and other tracking technologies, such as information about your device, internet usage, cookie identifiers, location, website activity, and other details about your use of the Site.

c. <u>Service Providers</u>: we may collect personal information from service providers who are assisting us in the operation of the Site.

d. <u>Other Third Parties and Publicly Available Information</u>: we may collect personal information from other third parties that provide information to us, such as advertising networks, data brokers, government and other public sources, and social media platforms and networks.

We may combine information that we receive from the various sources described in this Privacy Notice, including third-party sources, and use or disclose it for the purposes identified below.

# 2. Types of Personal Information Collected

We may collect the following types of personal information about you:

a. <u>Identifiers</u>: such as your contact information (including your name and email address), alias, unique personal identifier, social media identifiers, authentication information you create (such as account password), and device identifiers (such as advertising IDs, pixel and cookie IDs, and Internet Protocol ("IP") address).

b. <u>Internet and Other Electronic Activity</u>: that is gathered automatically when you interact with our Site such as browsing and search history, browser information, device type, Operating System (OS) version, and other information about your interactions with our Services.

c. <u>Audio, Visual, Electronic, and Similar Information</u>: such as recordings when you call us, chat with us.

d. <u>Inferences</u>: drawn from any of the information we collect to create a profile about you reflecting your preferences and characteristics.

## 3. How We Use Your Personal Information

a. <u>To Provide You With the Site and Related Services</u>: including to communicate with you and facilitate your interactions with us;

b. <u>For Marketing</u>: such as to market Fanatics goods and services or those of our affiliates, Business Partners, and other third parties;

c. <u>For Insights</u>: such as to identify trends and make inferences about you and your interactions with us, our affiliates, and the Site;

d. <u>To Comply With Legal Obligations and Defend Ourselves and Others</u>: such as to comply with legal requirements, cooperate with law enforcement and other lawful request, enforce our Terms of Use, exercise, or defend against legal claims and to protect safety, property, or rights;

e. <u>For Other Internal Business and Operational Purposes</u>: such as to manage customer accounts, auditing related to our interactions with you, for security purposes, and to improve or develop our products and services;

# f. In Connection With a Corporate Transaction; or

### g. For Any Purpose for Which you Provide Consent.

We may use de-identified, anonymized, or aggregated versions of your personal information for any purpose.

### 4. How We Disclose Your Personal Information

We may disclose your personal information in the ways that are described in this Privacy Policy, such as to:

a. <u>Affiliates</u>: we may disclose your personal information to our Fanatics family of companies, such as affiliates, parents, and subsidiaries;

b. <u>Service Providers</u>: we may permit our vendors, subcontractors, and other entities performing services on our behalf to access your personal information in connection with performing services for us, such as IT providers, internet service providers, and data analytics providers;

c. Professional Consultants: such as accountants, lawyers, and financial advisors;

d. <u>Law Enforcement, Government Agencies, and Other Related Recipients</u>: in connection with any request that we believe is consistent with or required by applicable law for legal, security, or safety purposes;

e. <u>Other Entities in Connection With or During Negotiations of any Corporate Transaction</u>: such as any merger, sale of assets, financing or acquisition; and

### f. Other Entities With Your Consent.

### 5. Cookies and Other Tracking Technologies

Our Site uses cookies and other tracking technologies to collect information about you, your device, and how you interact with us.

a. <u>Types of Cookies and Tracking Technologies</u>: our Site and the third parties that we authorize may use cookies, pixels, web beacons, tags, embedded scripts, and SDKs;

<u>b.</u> Purposes for Using These Technologies: we and authorized third parties use these technologies for tracking your activity over time to better understand your preferences, <u>improving performance</u> of the Site, to analyze how the Site is used, and <u>for advertising</u> on our Site and those of third parties;

c. <u>Information Collected</u>: these tracking technologies collect data about you and your device, such as your IP address, location (both approximate and precise), cookie ID, device ID, AdID, operating system, browser used, browser history, search history, and information about how you interact with our Site;

d. <u>Disclosures of Your Information</u>: we may disclose information to third parties or allow third parties to directly collect information using these technologies on our Site, such as companies that provide analytics;

e. <u>Your Choices</u>: some of the third parties we work with participate with the Digital Advertising Alliance ("DAA") and Network Advertising Initiative ("NAI"). The DAA and NAI provide mechanisms for you to opt out of interest-based advertising performed by participating members at <u>http://www.aboutads.info/choices/</u> and <u>https://optout.networkadvertising.org/</u>. You may also click on the AboutAds icon on advertisements and follow the instructions on how to opt out;

You can also refuse or delete cookies using your browser settings. If you do so, some of our Site's functionality may be impaired. Please refer to your browser's Help instructions to learn more about

how to manage cookies and other tracking technologies. If you change computers, devices, or browsers; use multiple computers, devices, or browsers; or delete your cookies, you may need to repeat this process. Opting out of interest-based advertising will not opt you out of all advertising, but rather only interest-based advertising from us or our agents or representatives.

Some browsers have incorporated Do Not Track ("DNT") preferences. At this time, we do not honor Do Not Track signals.

### 6. Retention

We will retain your personal information for as long as necessary to fulfill the purposes we have outlined above unless we are required to do otherwise by applicable law. This includes retaining your personal information to provide you with the Site and interact with you; maintain our business relationship with you; improve our business over time; ensure the ongoing legality, safety and security of our Site; or otherwise in accordance with our internal retention procedures.

## 7. Third Party Sites

The Site contains links and pages to other websites operated by third parties. Please note that this Privacy Notice applies only to the personal information that we collect through the Site, and we cannot be responsible for the information that third parties may collect, store, and use through their websites. We encourage you to read the privacy notices of the sites you visit carefully.

### 8. Your Rights

Under certain conditions and where provided by applicable law, you have the right to request that we: (a) provide access to any personal information we hold about you; (b) update any of your personal information which is out of date or incorrect; (c) delete personal information which we are holding about you; (d) restrict the way that we process your personal information; (e) prevent the processing of your personal information for direct-marketing purposes; (f) provide you with a copy of any personal information that we maintain about you; or (g) consider any valid objections that you have to our use of your personal information.

We will assess any request to exercise these rights on a case-by-case basis. There may be circumstances in which we are not legally required to comply with a request because of relevant exemptions in applicable data protection legislation. In some instances, this may mean that we are able to retain personal information relating to you even if you withdraw your permission. ### 9. Other Notices and Important Information

a. <u>Privacy Notice Changes</u>: we have the sole discretion to change, modify, add, or remove portions of this Privacy Notice from time to time. New versions of this Privacy Notice will be posted here.

b. <u>Terms and Conditions</u>: use of the Services is governed by, and subject to, the Terms and Conditions. Your use or accessing of the Services constitutes your agreement to be bound by the Terms and Conditions.

## 11. Additional Privacy Information for Residents of California and Certain Other US States

### a. Data Subject Rights:

We may collect some or all of the following data: first and last name, email, and postal address. In some cases, we may request different or more information, including a signed declaration. If you submit a request, you may also need to verify your identity by clicking a link in an email sent to your email account.
- Authorized Agents: authorized agents may exercise rights on behalf of consumers. We may require the agent to demonstrate authority to act on behalf of you by providing signed permission from you. We may also require you to verify your own identity directly with us or to directly confirm with us that you provided the authorized agent permission to submit the request.

- *Data controller*. Fanatics Holdings, Inc. whose registered office is at 95 Hudson Street New York, NY 10014, United States is the data controller.
- *Transfers outside of the EEA*. Like many companies, if you visit this site from the EEA, we may transfer personal information to countries outside of the European Economic Area ("EEA"), for the purposes set out above. If we do, we will, as legally necessary:
